Call for submission:

The Hildegard Grunow Foundation announces the opening of the application process for the third (2014) Rainer Gross Prize: Recent Innovations in Nutrition and Health in Developing Societies.

Background and Rules

Background of the Prize

The Rainer Gross Prize: Recent Innovations in Nutrition and Health in Developing Societies was created by the Hildegard Grunow Foundation to honour the memory of the late Dr. Rainer Gross and memorialise his unique approach to innovation in concepts and research in critical — but novel — areas of inquiry, with a view to better the nutrition and health of the less fortunate. With the awarding of this Prize, we recognize the merits of others who continue the generation and pursuit of innovative ideas and projects in nutrition and health in developing societies. The Prize is endowed with 2500 USD, and will be awarded biennially on the occasion of a large international nutrition-related meeting. The first award was made to Aaron Lechtig of Peru and Angela Cespedes of Bolivia in September 2010, on the occasion of the II World Congress of Public Health Nutrition in Porto, Portugal. The awardees of the second Rainer Gross Prize were Kenneth H Brown from the USA and Manuel Ruz from Chile. The ceremony was held on November 14, 2012, during the XVI Congress of the Latin American Society of Nutrition (SLAN) in Havana, Cuba. The third Rainer Gross Prize will be awarded during the III World Congress in Public Health Nutrition to be held next 7-12 November 2014 in Banjul, The Republic of Gambia and Las Palmas de Gran Canaria, Spain (<http://www.nutrition2014.org/index.php/en/>).

The award ceremony includes a lecture by the awardee(s) on the work being recognized and the presentation of the certificate and the monetary award. The awardee(s) are invited to write a corresponding review-page, which includes and covers the following details:

Applicant's Information:

- a. General information on the nominated individual.
- b. The characteristics, merits, and contributions of the project proposed/carried out by the individual.
- c. The methodology used for the development, financing and implementation of the nominated project.
- d. The localities or communities benefited by the project.

Publication or Manuscript:

In addition to the summarized information (a – d), a recent publication or submission-ready manuscript must be submitted. It can be: already published (within the last 5 years), currently submitted, or ready for submission, and must be originally written in or translated into English. If submitted in manuscript form, the length must not exceed 20 typewritten pages (216 x 279 mm (8½ x 11 in) or ISO A4 (212 x 297 mm), with margins of at least 2.5 cm; use double-spacing and 12-point type) including references, tables and figures.

Alternatively, nominations may be submitted electronically from the submission link (max. 10 MB).

Safe receipt in the Foundation will be confirmed either by e-mail or postal mail.

The application packets (one-page application and publication or manuscript) received will be forwarded to a jury panel consisting of two members for the board of HGF, and three internationally regarded professionals in the arena of the policy, scientific and technological aspects of human and community nutrition. The procedure governing the granting of the award will be based on the principles of attention to the dissemination of news, transparency, objectivity and non-discrimination as to race, religion, national origin or geographical residence of the applicants / nominees. The jury will announce its decision on the basis of the highest scoring of submission, and the decision of the jury is final. The next prize will be awarded in 2014. The Prize Lecture will be held during the 3rd World Congress on Public Health Nutrition, in The Gambia and on Grand Canary Island. The travel costs and meeting expenses of the awardee(s) to present the Prize Lecture will be covered by the HGF.

Malaysian Journal of Nutrition

Guidelines for submitting manuscripts

The **Malaysian Journal of Nutrition** welcomes manuscripts on all aspects of nutrition in the form of original articles, review articles, case-reports, short communications, book reviews and letters to the Editor. In order to avoid delays in publication, authors are advised to adhere closely to the instructions below.

All materials submitted for publication are assumed to be submitted exclusively to the Malaysian Journal of Nutrition (MJN) unless the contrary is stated.

Manuscripts must be submitted in English (British English).

All manuscripts submitted must be original and may be submitted electronically to the Editor (*geoklin_khor@imu.edu.my*).

Authors may also submit hard copies (original plus 2 copies) of the manuscript. They should be posted to the mailing address of the Editor provided at the end of these Guidelines. A soft copy of the manuscript will be requested when the manuscript is accepted.

Manuscript

Manuscripts should be typed on ISO A4 paper (210 x 297mm), 12-point font Times New Roman, double-spaced and on one side of the paper. There should be a margin of 2.5 cm on all sides.

The title page should state the title of the manuscript, full first name and surname of each author, authors' departments and institutions, city and country. Also enclose the complete postal address, telephone number, fax number and e-mail address of the author who will be responsible for all correspondences regarding the manuscript.

An abstract not exceeding 250 words in length should be provided on a page of its own. Make sure the title of the manuscript is included in the Abstract page. Do not include names and other details of author(s) on the Abstract page.

The abstract is divided into the following headings: **Introduction** (purposes of the study), **Methods** (study design, analytical methods), **Results** (specific data), and **Conclusion** (key aspects derived from the study).

Below the abstract, provide and identify five keywords or short phrases that will assist in cross-indexing the article.

Introduction, Materials and Methods, Results, Discussion, Acknowledgements and References should follow with each section beginning on a fresh page. Total number of words should not exceed 4500 excluding the Abstract and References.

Authors should state the authority which gave ethics approval for the study.

Citations and References

It is the authors' responsibility to check all references very carefully for accuracy and completeness.

In the text, references are cited by the surname(s) of the author(s) and year of publication parenthetically at the appropriate place. Three authors appear in full on first citation, e.g. Bray, Whipp & Koyal (1994), but subsequently as Bray *et al.* (1994). For four or more authors, indicate the first author followed by *et al.*

In the Reference section, list the references in alphabetical order. For each reference, all authors' names should be included. Examples of correct forms of references are given below:

Tables and Illustrations

Each table should be typed double-spaced on a separate sheet of paper. Tables should be numbered consecutively and should be completely labeled so as to be comprehensible without reference to the text. Omit internal vertical lines.

All illustrations and diagrams should be referred to as figures and numbered consecutively. Each illustration should be on a separate sheet of paper. Submit good quality original or glossy prints for direct reproduction. Photocopies of illustrations are not acceptable.

Arabic numerals should be used when numbering tables and illustrations. Total number of tables and illustrations should not exceed five with the exception of review articles.

Units and Abbreviations

All measurements should be reported using the metric system. Explain any abbreviations unless immediately obvious.

Reprints

The leading author will receive 20 copies of the reprints free of charge. Requests for additional reprints should be made to the Editor MJN. A nominal charge will be levied for each additional reprint.
